CONDITIONS OF ENROLMENT

Enrolment at Northcross Christian School (the school) is subject to the following terms and conditions. By ticking the boxes and signing, the person(s) applying for enrolment signifies that they have read the terms and conditions, understand them and do accept them.

1. Payment of a \$500 enrolment fee is required as confirmation that a position has been accepted. This fee is non-refundable.
2. Parents agree to allow the child to share fully in the life and programme of the school, including the Christian devotional activities and doctrinal lessons.
3. Parents will support the aims of the school and order their own lives and home so that the child will be given every opportunity to grow in Christ.
4. Parents undertake to provide the child with all necessary textbooks and other equipment of a personal nature that may be required to enable the child to benefit from the educational programme offered.
5. Parents undertake to provide the child with the correct uniform as specified by the school, and to ensure that the child is always sent to school neatly and modestly dressed in the required uniform.
6. Parents accept the right of the school to employ such discipline as it deems wise and beneficial for the child and agree to uphold in every way possible the school's authority and right to administer discipline in accordance with the policies of the school.
7. All fees are payable 30 days from the date of the invoice. (Note: In cases where this requirement would cause hardship, alternate arrangements may be discussed with the Principal.)
8. Parents agree to give at least one term's notice of termination of enrolment in writing. If this notice is not given, the parents agree to pay the full fees for the following term, in addition to any other fees due, within 28 days of the termination of enrolment.
9. The school may suspend or terminate enrolment at its discretion for failure to comply with these conditions or other serious breaches of the school's rules and regulations.
10. Photographs of students and of their work may be used for marketing purposes by the school.
